#### **EDITORIAL**

Dear NATs of whole Latin America, collaborators, friends and all those who accompany us on this way of fight and hope, we present you with satisfaction and proud this first number of our journal "AMERICANATs. Action and voice of Latin American NATs".

We consider the publication and diffusion of this journal as a great success for the MOLACNATs. In the first place we would like to use this journal as an instrument to let to know and make visible the actions and ideas of the organised NATs of the entire continent, in order to drive and interact with the social, economical, political and cultural dynamics, in which we would always like to be actors and not only passive audience, in a context characterised by indirect or structural violence.

In the second place, we propose that this journal becomes a space for reflection, encounter, exchange, debate and mutual recognition of the different national movements, associations and base-groups that are sowing throughout the whole continent the seeds of a new and alternative discourse on working children. Furthermore we think that the NATs' continental movement can reinforce in this way deep meaning of "big fatherland" which is Latin America, the deep meaning of an identity that get over the local borders and place itself in a largest horizon, that finds its roots in the history and the present of all our brother-people. Finally, we want that this journal guarantee the presence of our movement also on the international scene, allowing the communication with the partner-movements of NATs in Africa and Asia and making our voice listened for all the people who are interested and in all the instances related to working children.

The social leading role of the organised NATs is still largely unknown and little valued by many people, groups and institutions, which nevertheless pretend to speak about working children. This first number of our journal is published in a moment in which the ILO prepares its important meeting in The Hague, on the 10<sup>th</sup> and 11<sup>th</sup> of May of this year, in order to define the public policies on child labour for the next years.

Completely ignoring the participative mandate of the UN Convention on the Rights of the Child and without any respect for working children, the NATs were neither invited to nor consulted or informed about this meeting. This blindness, which implies the lack of knowledge of these international organisations about our reality, hurts us deeply.



They do not manage to open their minds to the innovation represented by the organised movements of NATs.

Nevertheless, we will go on as always, resolute and confident on our way, a way leading to the full and concrete acknowledgement of the rights and the dignity of the working child.

Our hope is that this journal will help us all in getting to know each other better and in valuing the contribution that we can make to a social and cultural renovation, which results really liberating and emancipator for our countries, wrongly named "developing".

We, NATs in Latin America, like all over the world, are suffering from high material deficiency, abuses, ill-treatments, various forms of exploitation, which we are not responsible for, because we know precisely which are the structural causes of our sufferings. At the same time we are defining our own geography, fighting without mediations against exploitation, not demanding for the "eradication", often violent and brutal, of children's work, but for the improvement of working conditions, the legal and socio-cultural protection of the working child and adolescent and finally a decent work for both children and adults. This will help us in developing our skills and competences to be good producers and citizens and thus living joyfully and in dignity.

We are sure that many other NATs of our beloved America are going to cooperate soon with this journal. Likewise, we are convinced that it will be an instrument more in our fight for building a better world, more equal, where the cruel and excluding competition between human beings is overthrown by a deeper sense of solidarity, brotherhood, equality and freedom.

#### From Latin America





As already mentioned in the editorial, the ILO (International Labour Organisation) will, together with their own programme for the "eradication" of child labour, IPEC (International Programme on the Elimination of Child Labour), organize a international conference en The Hague to define strategies and steps for the elimination of the so called "worst forms of child labour" until 2016. As the Latin American Movement of NATs we disagree substantially with the attitude of that conference and we demand the point that we have not been invited with no representative of the organized NATs. Therefore we publish this pronouncement which expresses our opinion and position of the Latin American Movements of the NATs.

Communiqué before the world conference about child labour in The Hague 10-11 th of may 2010

Pronouncement of MOLACNATs (Latin American Movement of working children and adolescents) referring to the conference of the ILO- IPEC in the Hague on 10 to 11<sup>th</sup> of may 2010

#### We raise our voices

as the Latin American and Caribbean Working Children and Adolescents Movement to **protest** the disrespect shown to us by the organizers of the Hague Conference by neglecting to invite us to participate, or indeed, even informing of us that it would take place.

#### **MOLACNATs**

,for more than 30 years, has been a place where working girls, boys and adolescents have organized themselves to implement collective action to protect and promote the rights of all girls, boys and adolescents. This activity revolves especially around our fight for social, cultural, political, and economic recognition as well as creating working and living conditions in dignity for working children, as well as for recognition of children in general as both subjects and social actors under the law.

#### It is unacceptable

that we, the legitimate representatives of organized working girls, boys and adolescents in Latin America and the Caribbean, were not invited to the conference since the subjects under discussion are parts of our reality. The exclusive attendance by adults, most of whom are quite distant from the realities of our lives, once again confirms that the approach taken to working children and adolescents continues to be adult-centred and child and adolescent participation is relegated to lofty intentions and legal texts.

We condemn the violation of our right to participate as children and adolescents as accorded under Article 12 of the Convention on the Rights of the Child, particularly given the observations and recommendations made by the Geneva Committee on the importance of complying with this article.

#### For more than 30 years,

our movement has defended its firm position to fight and denounce labour exploitation of millions of children throughout the world, while at the same time fully rejecting ILO Conventions C. 138, on minimum working age, and remaining critical and opposed to Convention 182 on the worst forms of child labour and its IPEC Program:

- As regards C. 138,
- We consider the minimum working age to be discriminatory, excluding minors younger than 14. This
  convention condemns thousands of girls and boys to the illegal and informal sectors, thus greatly
  exposing them to exploitation.
- As regards C. 182,
- · which considers the use, procuring, or offering of a child for prostitution, the production of pornography

or for pornographic performances, or the use of a child for illicit activities, in particular for the production or trafficking of drugs as the worst forms of child labour, **we believe** that these are criminal offences and flagrant violations of a child's human rights. We are clearly against all of these phenomena, but calling them "labour" creates dangerous confusion and leads to purely repressive practices as opposed to truly liberating alternatives.

#### Serious consequences

Our movement already has clearly made its presence felt in the Amsterdam and Oslo C.182 preparatory conferences (1997) where it drew attention to the negative implications C.182 would have on the lives of thousands of working girls, boys and adolescents. Its ratification has given way to the development of repressive policies in some of our countries that criminalize the social, cultural, and economic reality of many of our families. Unending raids, persecution and stigmatization of child and adolescent labour in the popular classes of countries like Colombia, Peru, Paraguay and Guatemala, are clear and regrettable examples of the effects of these "hard-line" policies.

#### The lack of objectivity

shown by these international organizations, who continue to deny our dignity with statements such as: "Child labour is a development obstacle" or "None of the main Millennium Development Goals can be achieved without eradicating the worst forms of child labour". Statements of this kind conceal the real reasons for economic, social, and political crises that our people have historically suffered as a consequence of the neoliberal economic model which is condemning millions of girls, boys and adolescents to poverty, marginalization and exclusion. The next Hague conference will be a space where this hypothesis will be given just that much more momentum.

#### We propose

from our organizing spaces, as working children and adolescents who know the reality of working children in Latin America and the Caribbean, to contribute and propose work-education programs which would train us both as producers and citizens.

#### We demand:

- > to be recognized as social actors, political and economic subjects by international organizations and society in general. (and to be invited immediately to participate in the discussions and drafting sessions of the next Hague conference).
- to be considered while public policy which could affect us is being drawn up.
- For our input to always be sought so that social policies can be implemented with a holistic perspective and in a way which favours development of our capacities and skills to overcome the exclusion and marginalization we face in many countries in the Global South.
- For governments to spend on education, health care, food, recreation and protecting the environment, instead of prioritizing payment on foreign debt.
- For our proposals to be listened to and considered for an economic system of solidarity where our social relationships and production take place without undermining human dignity and while protecting the environment and promoting solidarity among peoples.

#### We call upon

labour, peasant, indigenous, Afro-descendant, student, women, and intellectual organizations as well as progressive world governments to show solidarity to our call and not submit to international organizations and their power grabs with programs and policies that while covered with a varnish of good intentions, only propagate a system which exploits human beings.

#### We once again demand

our recognition as working children and adolescent so as to achieve the wish expressed by a working child:

"We want to make it possible for children to be happy and walk hand in hand with adults and everyone in society to make this world a big house where we all belong"

Yes to equality, no to discrimination!
Yes to protected work, no to abuse and mistreatment!

### Presentation of MOLACNATs (Movimiento Latinoamericano de Nin@s y

#### **Adolescentes Trabajadores**)

Molacnats is the coordinator of the Nats movements in Latin America. The working children and adolescents are leading the assemblies and are also in charge of deciding the strategies of the movement and the concrete actions. Adults do not enter in the direction bodies; they only play a role accompanying the education issues.

The local sections of each movement operate stimulating and improving the lives of children and adolescents who work. But if survival is essential, through participatory membership inside the movements, the working children and adolescents can understand by themselves, that they no only need food and bed from time to time, but also they need awareness of their own rights, enhance their own role as workers and recognized themselves as a group.

With this work, the working children and adolescents have stated to feel the need to live with dignity and respect for them, thus acting through actions and expressions of protest and denunciation.

After a few years this has led to such important results, for example, the exercise of an advisory role with the Peruvian government in occasion of the ratification of the Children Rights Convention.

The Molacnats action from each base movements, its articulated in 3 levels:

1. <u>Participation</u> in the defense and promotion of the Children Rights in general and particularly in the rights related with the NATs.

This work starts from organizing small experiences in the workplace, in communities where they live and interact with other social NATs. Then there are the Nats coordination networks in local and national levels, looking for the development of actions that can impact the public opinion, starting from the movements in the base.

- 2. <u>Development of programs</u> focus in their own experience that, in a particular way, look for the answer to the real problems of the Nats: Nats schools, productive projects, social programs and working ones, etc.
- 3. The third level is linked with the contributions made by the movements in the <u>development of public policies related with childhood</u>. Here there are also 3 levels:
  - 1. Complaints about the lack of public policy and protection of children and adolescents.
  - 2. Complaints about the applications of governmental policies against the working children and adolescents, and against the spirit of the International Children Rights Convention. These are the cases for example of Peru, Paraguay and Colombia.
  - 3. Active participation in the design of public policies in the protection of the working children and adolescents, like in the case of Venezuela.



### Final document of the 9th national meeting of working children and adolescents of Paraguay.



Paraguay is surely one of the Latin American countries which has the strongest and most efficient NAT movement, including a history dating back to more than 30 years and with a presence in many cities. The national meeting which took place on the 24 and 25th of October 2009 was very productive. After many discussions, debates and a lot of thinking, we proposed an action plan. We thank all participants, brothers and sisters of this country, and publish the following report, which comes from different regional bases.

Worried about the problems in the public service we had a national meeting on the 24 and 25th of October 2009 which took place in Asuncion. The working children and adolescents met to discuss the following topic: « The fight of the Nats for the right to work in dignity to improve their own and their family's living conditions ». We discussed national reality, state policies and social organisation. Considering the result of our analysis, we conclude that:

- The State pretends in theory to defend our rights, but in practise this is not the case, the State works only to defend the interests of a few people instead for the majority.
- This situation generates social inequity. Therefore many people see themselves in the obligation to look for better living conditions outside of their houses and their communities. This trend leads to family breakdowns and leads to abandonned children and adolescents.
- The impoverishment process (induced by state policies) is also evident in agriculture policies: the way the use of toxic pesticides and fertilizers is encouraged, killing people living on the fields, poisoning the water and food offered to those living in cities, contaminating the water, the soil, the forest, and finally contaminating all of us.
- It is also evident in the way farmers and indigeneous communities are expelled from their land, compelled to emigrate in city dwellings, in conditions of extreme misery.
- In spite of this state of affair and these changes, the State is very deficient and unable to respond to the demands of the population with public policies that would provide free education, free access to health care, and generate gratifying work for all.
- the « State welfare system » through which the State tends to answer social questions does not solve the problem in depth: it merely generates economic dependency without giving a sustainable answer. It is a superficial solution to the issue.
- We also understand that, through our work, we become qualified, we become organized and we have the power to be actors of social change.
- These changes will not come by itself. Bringing together social organisation must be a project at regional state level, creating a new reality of a more justice society.
- Social movements must maintain autonomy from the State, because we have our own ideals and pathways that extends beyond the responsibility of Governments. We are the people, and if the people progress, it has an impact on the future.

Considering all this, we, the working children and adolescents present the following proposals in four groups:

#### 1. Work and Production

- to generate worthy work for all people;
- Proposal of worthy works for the NATs, promoting the organization and the qualification;
- To review and to fight for a change of the conventions 138 and 182, that prohibit child labour;
- That an agricultural reform be undertaken in Paraguay to encourage food production in order to meet the basic nutritional requirement of the people and achieve food sovereignty.





#### 2. Education and Qualification

- truly free of charge quality education for all
- public educational policies that guarantee the good maintenance of school buildings
- teachers'qualification in line with the NAT's reality and suppression of all discrimination
- books with a content adapted to all levels of training, and internet access in all the schools
- school lunch up to the 3° cycle in all the schools. School cafeterias with quality food
- to guarantee high quality school equipment and to control its distribution
- to offer qualification courses: carpentry, masonry, electricity, computation, drawing, painting, crafts, etc. so that school becomes a working area;

#### Education designed by the NATs

- we wish the CONNATs develops a NATs school that is recognized by the MEC
- to make it possible for mothers to that they become qualified and organize themselves education-wise -that education be with love, tenderness, respect, solidarity and humility



#### 3. Health and Recreation

- more health centers, available drugs, and doctors that take care of the NATs with respect and simplicity
- more comfort in the health centers, improved hygiene, better treatment access, and respect shown to the NATs and their families
- health insurance for the Nats and their families within the popular sector
- that the municipality invests in the installation of theaters and libraries in the Districts
- that they do not discriminate us for being poor
- that the police does not remove to us from areas where we are playing
- more places with appropriate equipment and security, free recreationnal public spaces
- more free time to rest and play while at school, within the communities and at work
- that in the community there are more recreationnal spaces to play freely without adults around, more toys and games to entertain us

#### 4. Protagonism and organization

- that children's proposals are taken into consideration and that a budget is allocated to concretize the proposals made by NATs
- that the adults both participate in and support our suggestions, and that they listen to and respect our opinions
- that those who are State representatives think about the children sector when they are making decisions
- that we are consulted and that our opinions are taken into account in all matters that are important to us
- to explain to the authorities our experiences as NATs protagonists and as the NATs organization
- finally we demand a real and true participation right as members of NATs in the construction of Paraguay, through the analysis, consultations, proposals and action plans we can give both state's as well as private institutions, to make us feel that we are authentic active members of our Guaraní earth.

#### From Ecuador





The movements of the organized NATs are growing on the continent. Now Ecuador adds to other countries with a process of progressive consolidation of a national coordination with the groups from the base. Like the first important step of this process during the days 15-16-17 of the past may the first national meeting of the NATs, coming from Santo Domingo, Ambato, San Lorenzo, Cuenca, Esmeraldas, Quito, Guayaquil, took place in Cuenca, an Andean city in the east of the country. We are referring a summary of these days, congratulating the ecuadorean brothers.

In the international meeting "A suggestion of human development born of the working childhood", which developed in Quito the October ago one wanted to make an analyse, reflecting and debating about the different attitudes around child work. This event at all inspired a unit of initiatives, which found a first important expression in the hike of the first may when the ecuadorean NATs for the first time gained to conduct and to coordinate the activities of preparation and development of this hike itself.; that mend to capture confidence like a group and to generate a own place where free expression is possible with the final goal of being authentic participants of the action which was releasing.



Based on these precedents they organised the meeting of May. These were days of fundamental importance for the organising process of the movement of the NATs in Ecuador. The youngsters were sure about these aspects:

- The importance of the experience of the Salesianos and the Centre of the working youngster (Centro del Muchacho Trabajador)
- The unit generates power
- The need of working together
- It is necessary to act gradual but essential for creating a national organisation
- In any case already exist common points and goals by the different organisations

It was also possible to get to know the movement of Latin America and in parts of Peru, their process and their history. The youngsters analysed the development of every organisation related to the political framework of the country. They argued and discussed the suggestions around the ecuadorean movement with result of the following indications:

- It is necessary to unionize for fight and defend the rights of the working childhood and advance the working conditions
- The movement is going to integrate working children and adolescents that have or have had concrete
  working experiences or that are living in a situation of high risk like children tending to live on the street
- There is still no decision about the suggestion of a name
- They also discussed if it would have been more auspicious to work like a directorate or coordination. Finally one decided that it was better to work like a coordination of assemblies.

The following conclusions of the meeting are sticking out:

- There are still weaken parts in the participation process
- There is a lot of finality and volition for working together and united, like to give a new impulse to the movement and in the way that other organisations also get part of it
- It is still a long way to go to enforce and make the national movement aware
- It is important to go on reflecting and promoting suggestions.

#### From Peru





The MNNATSOP (in Spanish) is the National Movement of working children and adolescents organized in Peru. This movement represents and coordinates the different movements of the NATs in Peru. In these days the movement has celebrated the 14 years of his existence. One of our most important objectives is to promote and defense the Children Rights according with the CDN. Therefore, and because of being a lead social movement capable of advocacy, MNNATSOP has been working in the control and critic analysis of the informs that Peruvian State submitted to the NU Committee. Following is a summary that the NATs have sent us about the meetings, discussion and debates that they have taken on the subject.

#### **MNNATSOP:**

Promoting the defense of the Children Rights with other organizations of the NNA.

As public knowledge, in the year 2006 the MNNATSOP submitted an additional report to the Committee of the Children Rights of the United Nations. At that time two of our National Delegates met informally with members of the Committee.

Subsequently, the Committee of the Children Rights of the Child United Nations issued 76 recommendations to the Peruvian State to comply with our rights. The MNNATSOP with the National Network of Children and Adolescents-REDNNA (in Spanish), in 2008 initiated a national mobilization for the dissemination of these recommendations, having in one of the events in Lima with the presence of Rosa Maria Ortiz, Committee member.

In 2009 the MNNATSOP was invited to participate in two events by organizations that advise the Committee on the Children Rights of United Nations. The first event was in London and the second was in Geneva. In the workshop held in the month of September 2009 in Geneva our Movement raised the need to institutionalize the participation of children and adolescents in the preparation of alternative reports from the same organizations in the NNA. This initiative was welcomed by other NNA and adolescents present in this figure: Wales, Bangladesh, Hong Kong, Moldova and Kenya.

In the meeting with the members of the Committee on the Children Rights of United Nations at the Palace Wilson, the Delegation from Peru was designated to bring this proposal to the members of the Committee.

Although the Peruvian government close to present the fourth report on the compliance of the 76 recommendations of the Committee of the Children Rights, the MNNATSOP consider that in reality very little has been accomplished since 2006.

Since we feel that our rights are violated by the State, from our movement we have proposed a national campaign, calling the other organizations of children and adolescents, in order to present, from our perspective and eyes, a report alternative from the one made by the State and civil society, GIN in this case, because we don't feel that we are represented in it.

It is for this reason that since 2009 we have been analyzing the compliment of the 76 recommendations of the Committee on the Rights of the Child, working according with the different themes.

These reflections performed by NNA organizations and support institutions, have helped us to discover that the Peruvian State is not interested in meeting these recommendations, for example, education and health investment in 2010 is only 3.0% and 2.4 of GDP respectively. In addition the "Ley de Mendicidad" is still valid. This law is used by the authorities to act against the NNA.

Also there has not been considered the implementation of comprehensive programs to meet the needs of children in the streets, so far is still unresolved the close of the Reception House Generation, which is one of the bases of our Movement. Moreover, we feel that the State is intended to have heavy-handed laws to criminalize poverty, as currently in the Review Commission for Children and Adolescents Code trying to raise the minimum age for working to 16 years and go down to 14 years to punish the violation of criminal law. And it is still valid the proposal of the "pernicious gang".

In these days of reflection we have discovered that in the national level our rights has been violated, specially in the Andinan and Amazonian areas, with the contamination of the rivers and the destruction of the biodiversity, with the mining and oil exploitations by the transnational corporations. We also proposed in this context, the need to require from the State the fulfilling of the recommendations of the Children Rights Committee.

Since 2009 we performed 5 different workshops in Lima and one at national level, with the idea of keep calling the support of more organizations for children and adolescents.

Each organization and institution analyzed the current situation of the Peruvian children and touched the following topics: Education, Health, Violence, Environment, children in street situation, repeal of the "Ley de Mendicidad", Gang pernicious, recommendations from the Truth and Reconciliation Commission-CVR, child sexual exploitation and trafficking, mental health, HIV / AIDS, children belonging to indigenous groups and training and dissemination of the Children Rights Convention.

In February 27, 2010 was the last National Day of Reflection with the participation of National Delegates from the MNNATSOP, MANTHOC, CONADENA of Lima, Lambayeque, La Libertad, Trujillo, Pasco, Junin-Jauja, and Generation. Children of the River, Southern Voice of San Juan de Miraflores, ATO-COLIBRI, REDNNA, CONA-Ica, delegates and support institutions MOLACNATs: IFEJANT and infants. The First National Day of Reflection, concluded with the commitments made by each organizations present in a festive mood and emotional state to demand from the State compliance with their commitments. #### Meeting-seminar from the PPT in Bogota

The "Proyecto Pequeño Trabajador" (the project little worker) — PPT is a comunitary organization that works for the restitution of Children rights, adolescents and young workers in contexts of displacement, violence and social exclusion through initiatives and programs of human-integral development (educational reincorporation, participatory and familiar stages and pedagogic productive projects) that contributes to prevent crimes and explotation against childhood.

Among their activity frame the PPT has organized the Meeting-Seminar "A little is a great worker: Contributions for a historical reflection of the child, adolescent and young workers" which took place on February third from this year. It was a positive and important opportunity to share and promote the argument on some aspects of the experience - reflection of the PPT from childhood and hard-working youth.
